

Elder Abuse Annual Research Compilation

SEPTEMBER 2024 – AUGUST 2025

This annual research compilation highlights articles relating to elder abuse, neglect, and exploitation that were published between September 2024 and August 2025.*

Search criteria and strategy: The articles were identified using the USC library catalogue database and applying the search terms *elder abuse*, *elder mistreatment*, *elder neglect*, *financial exploitation*, *adult protective services*, and *long-term care*. Only peer reviewed research articles published in English were included. Articles were excluded for non-relevance if elder abuse, mistreatment, or violence were not in the title or keywords.
